Daycare and Boarding Requirements

The purpose of Doggietown USA is to provide a safe, fun, and stimulating social environment for your dog(s) while you're at work or out of town. To ensure the safety and health of your pet and our other guests, we require that all guests comply with the following rules and regulations:

REQUIRED VACCINATIONS: **Bordetella (Every 6 months)** *Some vets do an annual vaccine; we still need this updated every 6 months. **DHPP (1 - 3 yrs)** **Rabies (1 or 3 yrs for all dogs over 4 months of age.)**
ENROLLMENT: All dogs must have a complete application and interview by staff prior to attending daycare or boarding.

INTERVIEW: Interviews are required before any new dog can stay, and are by appointment only. If you are late for your appointment, you will need to re-schedule it. You will need to bring current vaccination records to the interview. Doggietown USA has the absolute discretion to refuse services to any pet it determines is unsuitable for such services.

AGE: All dogs must be 12 weeks of age or older and completed 3 series of puppy DHPP vaccines and at least 1 Bordetella vaccine (within the last 6 months).

SPAY/NEUTER: All dogs 7 months of age and older must be spayed or neutered.

HEALTH: All dogs must be in good health. Owners will certify their dog(s) are in good health and have not been ill with a communicable condition in the last 30 days.

FLEA CONTROL: All dogs must be on a flea control program. If fleas are found on your pet, they will be given a flea bath automatically. Flea baths will be added to your bill.

BEHAVIOR: All dogs must be non-aggressive. Owners will certify their dog(s) has/have not harmed or shown any aggression or threatening behavior.

BREEDS: We accept all breeds and sizes that pass our interview process, except for purebred pitbulls.

HOURS OF OPERATION: Monday through Friday 6:30am to 7:00pm. Sat 9:00 am to 5:00 pm, Sun 9:00 am to 10:00 am + 3:00pm- 5:00pm. If your pet is not picked up by the end of our business day, we will board your dog overnight and charge you the additional \$12.00 overnight fee.

BOARDING: It is **required** that all boarding guests spend at least 1/2 day of daycare with us prior to boarding. This will make your dog's stay with us more comfortable. We do prefer to feed your dogs their normal diet, so we request that you bring enough food for their stay. Please bring all dry food in a sealed container or ziplock bag. Please mark all bags and cans with your pet's name. We will happily administer any supplements or medications that your dog requires at no additional charge, so please include enough for their stay. No personal beds, blankets, bowls, or toys are needed! If you pick your dog up by 10am, Mon.-Sun., no additional daycare fees will be charged, any later, and applicable daycare fees will apply. We recommend a bath prior to pick-up for any dogs boarding at our facility for more than three days. Please book this when you book your dogs stay.

PAYMENT: Discount Packages are to be purchased in advance. If you choose to pay our regular pricing, you will be billed at the time you pick up your dog.

RESERVATIONS: Are required for ALL daycare, boarding & bathing services.

Daycare & Boarding Service Contract

THIS AGREEMENT is entered into by and between Doggietown USA and _____
"Owner"):

1. Owner understands and agrees that Owner is solely responsible for any harm caused by Owner's dog(s) while Owner's dog(s) is/are attending Doggietown USA. _____(initials)
2. Owner understands and agrees that during normal dog play, Owner's dog(s) may sustain injuries. All dog play is carefully monitored by Doggietown USA to avoid injury, but scratches, punctures, torn ligaments, etc. may occur despite the best supervision. _____(initials)
3. Owner further understands and agrees that in admitting Owner's dog(s), to Doggietown USA, that Doggietown USA has relied on Owner's representation that Owners' dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any other person or any other dog. _____(initials)
4. Owner further understand and agrees that neither Doggietown USA nor any of its employees, staff or volunteers, will be liable for any injury, illness, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, and the Owner hereby releases all of them of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending or participating at Doggietown USA. _____(initials)
5. Owner authorizes Doggietown USA to arrange emergency veterinary care, releasing Doggietown USA from all liabilities relating to transportation, treatment, and expense. Owner authorizes Doggietown USA to approve medical/emergency treatment as recommended by a veterinarian. Owner agrees to reimburse Doggietown USA for any expenses incurred. _____(initials)
6. Owner further understands and agrees that any behavioral or health problems that develop with the Owner's dog(s) while at Doggietown USA will be handled and treated as deemed best by the employees, staff and volunteers of Doggietown USA, in their sole discretion, and Owner expressly agrees to assume full financial responsibility for any and all expenses arising or relating hereto. This includes aggressive or destructive behavior. _____(initials)
7. Owner further understands and agrees that Owner's dog(s) will at all times while attending Doggietown USA have current vaccination status. Owner further understands that even if Owner's dog(s) is/are vaccinated for Bordetella (Kennel Cough) there is a chance that the Owner's dog(s) can still contract Kennel Cough. Owner agrees that Owner will not hold Doggietown USA responsible if Owner's dog(s) contract Kennel Cough. _____(initials)
8. Owner fully understands and agrees that Owner's dog(s) must be spayed/neutered to attend Doggietown USA after 7 months of age. _____(initials)
9. Owner fully understands and agrees that Doggietown USA reserves the right to use a citronella bark collar if he owner's dog(s) create a disturbance or nuisance to neighboring businesses. _____(initials)
10. Owner fully understands and agrees that if the Owner's dog(s) is/are not picked up by the end of Doggietown USA's regular business day, the Owner hereby expressly authorizes Doggietown USA to take whatever action is deemed necessary for continuing care of Owner's dog(s) and the Owner agrees and promises to pay Doggietown USA all costs of continuing such care upon demand by Doggietown USA. _____(initials)

Owner further understands and expressly agrees that each and every of the forgoing provisions containing in Paragraphs 1-11 above shall be in force and effect and shall apply to each and every occasion on which Owner boards or deposits Owner's dog(s) with Doggietown USA for daycare, extended boarding, or training, as the case may be; and that this Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superceded by a writing signed by both parties. _____(initials)
